## INTRODUCTION

On 05 November 2020, B & J Catalano received approval under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) to undertake limestone mining at Lots 4 And 5 Ludlow Road, Myalup, Western Australia (WA). The approval has 25 conditions, of which 10 conditions are specific to the action.

In regard to annual compliance reporting, condition 18 of the approval states that:

The approval holder must prepare a compliance report for each 12 month period following the date of commencement of the action, or otherwise in accordance with an annual date that has been agreed to in writing by the Minister. The approval holder must:

- a. publish each compliance report on the website within 60 business days following the relevant 12 month period;
- b. notify the Department by email that a compliance report has been published on the website and provide the weblink for the compliance report within five business days of the date of publication and provide documentary evidence of the date of publication on the website;
- c. keep all compliance reports publicly available on the website until this approval expires;
- d. exclude or redact sensitive ecological data from compliance reports published on the website; and
- e. where any sensitive ecological data has been excluded from the version published, submit the full compliance report to the Department within five business days of publication.

This report has been prepared to fulfil the requirement of Condition 18. This report will be published on the B & J Catalano Pty Ltd website and a weblink of the report will be forwarded onto the Department of the Environment (the Department) together with proof of publication date to fully satisfy this condition.

## DESCRIPTION OF ACTIVITIES

The approval is for the expansion of the existing limestone extraction operations on Lots 4 and 5 Ludlow Road, Myalup, approximately 50 km north of Bunbury, WA. The project area is an area of 12.6ha that has been approved for limestone extraction (see Figure 1). Extraction within this area commenced after clearing took place in December 2021, with the commencement of action date captured as the date of commencement of clearing on 10<sup>th</sup> December 2021, when an initial 2.4ha of clearing took place.

The extent of clearing for the reporting period has been captured in Figure 1 using satellite imagery, with a total of 3.2ha of the approved 7.4ha being cleared during this period.

Revegetation of the offset area took place in winter 2021 (see photos in Attachment 1), however only 7ha of the 10.6ha area was revegetated. The remaining of the revegetation will take place in winter 2022 and will be reported in next year's compliance report.

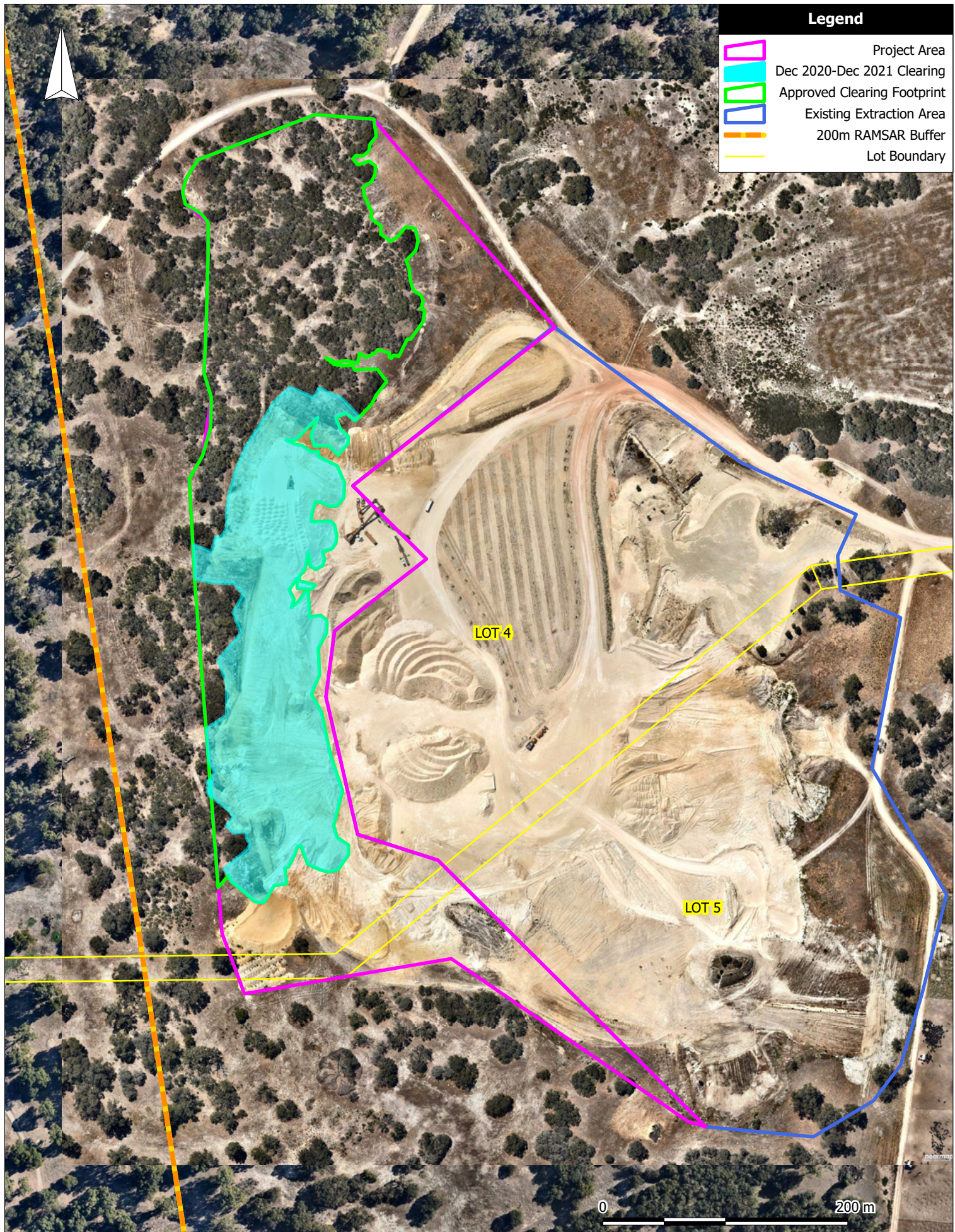
